Call to order: 7:05 PM by Sharon Fairbrother.

Financials:

- Reviewed Jan and Feb statements. Voted 3/0 to move \$58,000 from the CAB operating account to CAB CD for 15 months at 2%.
- BCM fees will go up 3% in March as their contract automatically renews. There was no charge in January of \$897.12, so we will see that in the March financials.

Minutes:

Approved minutes 3/0 for Nov 2017 and Feb 2018.

Closed Actions

- ✓ (Oct) Board: Find history of dry pond cleaning
- ✓ (Nov) Board: Find out how much we paid for insurance in 2017 (\$1,344)
- ✓ (Nov) Board: Start working the annual budget for 2018
- ✓ (Feb) Send out a notice that informs all home owners how to get in touch with the management company: BCM. This was covered in the newsletter and contact information was added to the invoice footer.
- ✓ (Feb) Discussed adding a Twitter and/or Facebook page to help communicate community information. #WestwoodTowns Voted not to do this due to the time and maintenance commitments required.
- ✓ (Feb) Trees need to be trimmed along the corner of WTW and Fawncrest. Additionally check if roots may cause damage to the homes. Franks is checking the trees and trimming as required. Franks also looked at the roots of trees along Fawncrest and WTW and did not find any issues.
- ✓ (Feb) Concern that homeowners may be using their properties as an AirBnB. Investigate rules for doing that. Homeowners have been informed.
- ✓ (Feb) Have the fire department come through the neighborhood and perform a smoke alarm check on all the homes. No action. Too hard to organize this for the entire community. This needs to be done by household.
- ✓ (Feb) Some of our trees have a green fungus-looking mark on them. Investigate if this is a disease we need to take care of. This is normal and typically found on the shady side of the tree.

Open Actions

• (Oct) Board: Buy more "no pooping" dog signs

- (Oct) Board: Talk to Frank's about fresh planting at the entrance
- (Oct) Board: Start reviewing the reserve plan.
- (Feb) Trees from park invade some property lines. Homeowners have the right to trim those trees back.
- (Feb) By-Law Update: Parking should be changed so that visitor parking is 48 hours and regular parking slots are 72 hours. Longer times can be approved through the management company on a case by case basis. Three violations can result in towing
- (Feb) By-Law Update: Driveway steps and painting: Stairs and driveways should have approved coloring so that "off" colors like grey cannot be used. Needs an update to the architectural guidelines or by-laws?
- (Feb) By-Law Update: Exterior lighting cannot be colored except for holidays. Needs an update to the architectural guidelines or by-laws?
- (Feb) By-Law Update: Trash and recycle containers must be taken in by Noon the day following pick up. All Trash and recycle containers must be stored out of sight of the street.
- (Feb) By-Law Update: Discussed restricting board membership to home owners only. Motion to move forward with board membership update. Estimate \$900 to \$1,200 to draft and cover letter.

New business and Open forum

Ideas for community improvements

- Add up-lighting to the front of the community
- Install drip lines for all the trees along the front of the community
- Reseal the roadways and pay to have men monitor/prevent homeowners from driving on the roads while they are being repaired and curing

For sale signs

- Signs should only be placed out front on the weekends
- Signs cannot be placed out front along the strip of grass between the street the sidewalk
- Note: VDOT states signs should be at least 10/15 feet from road edge and not near right of way
- What we have currently: One real estate sign may be placed in each of two places: the front area of the available property and the front entry of the neighborhood. All signs must be immediately removed upon completion of the sale or rental transaction. I think we need to update Guidelines for this to say "For Sale" so that "Coming soon" is not included.
